

This report is written by Det. Guy FRALEY, assigned to Central Investigations Division.

On Sat, 12-26-15, at approximately 9:20 PM, Lt. John BELSHA instructed me to respond to 3288 N. Lake Dr. (Wisconsin Institute for Torah Study) regarding an armed robbery.

Interview of Alexander \*\*\*\*\* Upon arrival, I spoke to one of the victims (Alexander \*\*\*\*\*) who informed me that he and two of his friends (#1. Michael\*\*\*\*\*), (#2. Arie\*\*\*\*\* ) were walking southbound on N. Hackett Ave towards Starbucks when four black male suspects ran up to them. He described the suspects as follows:

Suspect #1. Black male, 6'02 to 6'04, 140lbs, 18 to 20 yoa, dark complexion, dark grey hooded sweatshirt, tight ripped blue jeans, small black semi-automatic handgun.

Suspect #2. Black male, 5'05, 130lbs, 18 yoa, light complexion, 1" long black curly hair, blue hooded sweatshirt with white roman numeral on the front, tight dark jeans, large thick dark framed glasses with clear lenses.

Suspect #3. Black male, dark hooded sweatshirt and jeans.

Suspect #4. Black male, dark hooded sweatshirt and jeans.

He stated that suspects were all talking / yelling and demanded cell phones and wallets. He stated that suspect #1 was armed with a handgun and stood there pointing the gun at them while suspects 3 and 4 went into the pockets of \*\*\*\*\* and \*\*\*\*\*. He stated that suspect # 2 was slapping, pushing and punching \*\*\*\*\* and \*\*\*\*\* while suspects 3 and 4 took their property. He stated that he was patted down or searched for property but he did not have anything on his person for them to take. He stated that the suspects then fled in one direction and he and his friends fled southbound on N. Hackett Ave. He stated that after the suspects fled, he and his friends turned around and returned to school where they called the police.

\*\*\*\*\* stated that he might be able to identify suspects # 1 and # 2 if presented with a photo array in the future.

Interview of Michael \*\*\*\*\*

\*\*\*\*\* stated that he was walking with \*\*\*\*\* and \*\*\*\*\* towards Starbucks and were approximately four blocks away from Starbucks when the suspect vehicle (white SUV with a grey front bumper) parked approximately thirty yards away and the four black male suspects exited. \*\*\*\*\* described the suspects as follows:

Suspect #1. Black male, 6'2 to 6'3, 140lbs, 18 to 20 yoa, dark complexion, dark hooded sweatshirt and dark pants, armed with a small black semi-automatic handgun in his right hand.

Suspect # 2. Black male, 5'7, 130lbs, 17 yoa, medium complexion, blue hooded sweatshirt, with a white circle / symbol on the front, white rimmed glasses with clear lenses.

Suspect # 3. Black male, 5'5, 130lbs, dark clothing.

Suspect # 4. Black male, 5'5, 130lbs, dark clothing.

He stated that as the suspects approached him and his friends, suspect #1 displayed and pointed a small black semi-automatic handgun at them. He stated that the suspects stated "Fucking stop, give me your phone and wallet". He stated that suspect # 1 stood 4' to 6' away pointing the gun at him and his friends while suspects # 2, 3, and 4 patted down and searched their pockets. He stated that suspect # 2 struck him with a right cross, striking him on the left cheekbone. He stated that he removed his wallet from his left front pants pocket and gave it to an unknown suspect. He stated that suspect # 2 punched \*\*\*\*\* in the face and took his cell phone and wallet. He stated that the suspects then ran back to the vehicle, which did a U-turn and headed westbound on W. Locust Ave. He stated that he and his friends initially ran southbound on N. Hackett Ave until they realized that the suspects fled westbound on W. Locust Ave. He stated that they turned around and returned to their school (3288 N. Lake Dr.) where they notified the police.
